After attending and passing the examinations, practitioners will be:
(1) Certified as CCLP,

Prerequisite for CCLP (Supervisor):

- appropriate cold chain experience
- Pass all Level 2 exams

Prerequisite for CCLP (Trainer):

- Degree holder
- appropriate cold chain and teaching experience
- Pass Level 2 and 3 exams

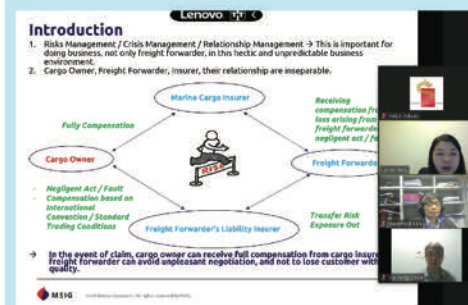
Cold Chain Logistics Professional (CCLP) ISO23412:2020 Understanding Training (Level 2B) Webinar on 19 February 2022

To reduce the risk of the spread of COVID-19, the original full-day on-site training course was held online via zoom on 19 February 2022. We were pleased to have invited Mr. KT Ting, Director-Strategic Services Development of Hong Kong Quality Assurance Agency to introduce the concepts and requirements of ISO23412:2020 during the morning program. In the afternoon session, Mr. Chris Chan, Manager of Yamato was invited to share the practical knowledge and valuable experience in acquiring the ISO 23412:2020 certificate and the benefits. The webinar was concluded and wrapped up by Mr. Stephen Chan, HKLA Honourable President & Advisor, who is also the Chairman of CCLP Accreditation Panel.

An online assessment examination was carried out right after the training session. All participants completed their examination timely and successfully.



Marine Case Study - Frozen/General Cargoes Webinar on 2 March 2022
