${f G}$ uidelines for Application of Emerging **Technologies in Cold Chain Logistics**

Hong Kong Logistics Association has been granted by the Trade and Industrial Organisation Support Fund of the Trade and Industry Department to develop an application guideline for emerging technologies in "Cold Chain Logistics Management System". Under the scheme, the industry not only establishes or upgrades an effective smart cold-chain logistics management system, but also benefits from an optimized managerial and operational procedure, aiming at maintaining and enhancing Hong Kong's competitiveness.

Commencement Date: 1 Mar 2023 Completion Date: 31 Aug 2024

The Kick-off Seminar was successfully completed on 19 May 2023. Over 70 participants joined the seminar on-site and online. Two honourable guest speakers, Mr. Stephen Chan of Power Hub Limited and Dr. Paul Tsang from The Hong Kong Polytechnic University, shared the following topics with our participants:

- The background and aim of this project
- The guidelines for applying emerging technologies in cold chain logistics
- The advantages on adopting modern, practical and costeffective automation technology

The four workshops will be held from Mar – Jun 2024. The purpose is to educate and train the industry to understand the recommended Guidelines and demonstrate the adoption of the suggested smart technologies in cold chain management. The workshops can provide a two-waycommunication and interaction environment among the workshop's participants and project team. It helps the industry to evaluate their current cold chain practices and understand the interrelationship between cold chain practices and technologies, and how different technologies can help improve the effectiveness of the cold chain. Moreover, it enables the industry to use the Guidelines as a reference to select appropriate technologies based on scenarios and requirements.



Title: HKLA contributes to the pass of Import and Export (Amendment) Bill 2023

Hong Kong Logistics Association (HKLA) welcomes the Import and Export (Amendment) Bill 2023 passed by LegCo on 21 June 2023. The Amendment will resume the intermodal transshipment of e-cigarette via Hong Kong under the control by Hong Kong Customs.

The Amendment was passed by a majority vote in LegCo after the third reading. HKLA, along with other stakeholders of the logistics industry, had expressed her positive opinions in the Bills' public hearing to support the Amendment. We hope you will benefit from such revision.
