The 1st Guidance Workshop was successfully completed on 20 March 2024. Over 30 participants joined the guidance workshop.

Two speakers from implementation agents, Mr. Carson Yeung of Hong Kong Quality Assurance Agency and Mr. K. K. Suen of GS1 Hong Kong Limited, shared the following topics with our participants:

3. Technology Introduction with demonstrations

The upcoming three workshops will be held from April – June 2024. The purpose is to educate and train the industry to understand the recommended Guidelines and demonstrate the adoption of the suggested smart technologies in cold chain management. The workshops can provide a two-way-communication and interaction environment among the workshop’s participants and project team. It helps the industry to evaluate their current cold chain practices and understand the interrelationship between cold chain practices and technologies, and how different technologies can help improve the effectiveness of the cold chain. Enable the industry to use the Guidelines as a reference to select appropriate technologies based on scenarios and requirements.
