President's Message



Dear Members,

Time flies, I have already completed the term 2017/2018 of President of HKLA. To me, it is a very challenging mission. Thanks to the enormous supports of the Council members, our association had achieved several important goals in 2018 and I would like to reveal as follows.

Consultation Meeting with CE on 2018/2019 Policy Address relating to "Logistics & Aviation"

We were invited by Chief Executive of Hong Kong Special Administrative Region Mrs. Carrie Lam Cheng Yuet Ngor, GBM GBS to have a consultation meeting on 2018/2019 Policy Address in the freight and logistics sectors. During the meeting we reflected our key concerns on the impending New Cargo Security Policy of The International Civil Aviation Organization (ICAO). It was also a valuable opportunity to share our views on how to enhance Hong Kong's role as a regional & international logistics hub.

International Networking in 2018 Annual Dinner

During the 2018 annual dinner we had "MOUs" ceremony with our strategic partners namely Beijing Jiaotong University, Singapore University of Social Sciences, and Rotterdam Business School, Netherlands. We shared the great moment with our honorable guest Secretary for Transport & Housing Mr. Chan Fan, JP & Legislative Councilor Mr. Frankie Yick, JP.

Joint Survey on Air Cargo Security (ICAO 2021) by three Associations: HKLA, HAFFA and HAAT

ICAO announced a policy direction for phasing-out consignors not approved by a legitimate authority or the Civil Aviation Department (CAD) for aviation security by 30 June 2021. Under the new policy direction, consignors will either need to be approved by a legitimate authority or CAD, or have their air cargoes passing through 100% security X-ray screening. Through the joint institutes questionnaire survey, we had collected members' views on what kind of Government supports were essential in order to enable the industry to comply with the legal requirements and to be financially viable. The survey results were submitted to the Government.

Collaboration in Education and Trainings on Cold Chain Logistics

Currently we are in the process of collaborating with HKQAA to develop the Cold Chain Management Standards & Practice Guidelines to enhance the professionalism on the cold-chain operations among logistics providers. We are also planning to launch HKLA's own training programs for various working levels. This is a new approach to achieve win-win-win results among members, the Association and industry. In suitable circumstance, HKLA may also take a lead to roll out the collaboration model in the "Greater Bay Area" in future.

YSHKLA continuous growing

In 2018, we successfully run the "9th International Logistics Case Competition" in Rotterdam. We are glad that this event was supported by the Consulate General of the Netherlands in Hong Kong Ms. Annemjeke Ruigrok. Through her connection our exposure had extended to Europe. This is indeed a valuable opportunity not only to nurture our young logisticians but also to build up a good relationship with Rotterdam Business School as strategic partner.

New Website launched

By joining the government's Technology Voucher Program (TVP) for funding and with the great efforts of Council Members, Council Associates and the Admin Office, we revamped our website in 2018. The new version launched in mid-November. It is of user and mobile phone friendliness design and is a new feature of "Member log-in" exclusively for our members to access special information and to communicate with our Admin Office.

Apart from the above there were many other achievements in 2018. You may browse our new website as well as the bi-monthly Newsletter for more details. Once again, I would like to take this opportunity to express my heartfelt thanks to our Council Members, Corporate Members and all levels of members for their valuable contributions to the Association. 本考試通過國際採購與供應管理聯盟 (The International Federation of Purchasing and Supply Management, 簡稱 IFPSM) 全球標準資質認證，考試合格人員取得證書後可申領IFPSM的國際認證。
