Dear Members,

President's Message

Hong Kong has never been facing such difficult challenges internally and externally. However, the good news is that HKLA, with the full support of our members, we still make a financial surplus of 65% compared with the preceding year. For the year 2019, I would like to share with you some of our achievements.

Collaboration with HKQAA

The cold chain management will be the next agenda item after IoT in the logistics industrial development. Therefore, the training need as well as the standardized practice has to be set in place. On 20th September, our Annual Dinner Gala has included a "MOU" signing ceremony with our strategic partner Hong Kong Quality Assurance Agency (HKQAA). This important moment signified the beginning of the standardization of the cold chain practice and management. The purpose of the cooperation is to develop a Cold Chain Management Standards & Practice Guidelines. It aims at the uplift of the overall cold-chain quality among logistics providers. It is hopefully leading to improve the professional and standardized operations, generate values and save costs for the cold chain service users including the end-customers.

Training Fee Subsidy from LOGSCOUNCIL

After a continuous effort, HKLA will offer training courses that with the entitlement for LOGSCOUNCIL's subsidies, implying the quality and professional status of our training program are fully recognized. The HKLA training course focuses on practical knowledge and problem solving skill at work. In particular, the local and international case study workshops and competitions are the unique programs not covered by any industry or academic institutions in Hong Kong. These two programs are hot and gaining a lot of sponsorships from local/international companies and universities. We are glad to have LOGSCOUNCIL's support on training fee subsidies starting from 2020. The aim of such subsidies is to encourage the "Life-long Learning" and upgrading the professional skills of logistics practitioners. In practice, LOGSCOUNCIL will subsidize 50% of the training fee to qualified course participants. The training courses shall cover three main areas: (1) Technology & Automation, (2) Latest Logistics Business Development e.g. greater bay area, cold chain etc., and (3) Logistics Company Management Techniques for Managers and Senior Executives.

Establishment of Youth Development Committee (YDC)
A new committee has been endorsed by the Council in 2019. The new Youth Development Committee (YDC) aims to sustain continual growth of HKLA. It will foster the new graduates from universities to serve in the HKLA as well as the industry. The objectives of forming YDC are (1) to encourage more Youth Society members to join YDC after their graduation and participate actively in various HKLA events, (2) to build up a network for job opportunity and career development. The 1st kick-off meeting of YDC was held on 8 November 2019 and YDC is now recruiting new members aged below 35 years old.

Consultation Meeting with CE on Policy Address

Throughout the year, HKLA has expressed our industry concerns to various government departments such as customs and excise department, planning department, etc. We were also invited by the Chief Executive (CE) to attend a consultation meeting on 2018/2019 Policy Address in the freight and logistics sectors. We have voiced out key concerns (serious down turn due to Sino-US trade war etc.) jeopardizing the logistics business. On the other hand, we also made recommendation for short-term immediate actions, e.g. fuel tax reduction by half for commercial vehicles. Furthermore, we have also proposed to CE to agree the feasible long-term initiatives to resolve land and labor shortages. Solution for effective means to reduce high operation cost on ICAO 2021 New Cargo Security Policy is required and to be developed by government. The government is requested to consider the establishment of dedicated fund for the support of logistics industry during this lengthy hard time for SMEs. The meeting has also provided a valuable opportunity to voice out our views on the need of strengthen Hong Kong as a regional & international logistics hub in long-term.

Besides, there are many other interesting stories to be shared in 2019. Please visit our newly-designed website and the bi-monthly newsletters. Once again, I would like to take this opportunity to express my heartfelt thanks to our Council Members, Council Associates, Corporate Members and all other levels of members for their valuable contributions to HKLA.
