### 物流用地及人力資源政策新聞發佈會

本會於本年5月至7月期間就財政司預算案內有關物流用地及人材培 訓基金等政策作出問卷調查,並於10月3日舉行新聞發佈會交代調查結果。 另外,亦就9月初對應否輸入外地勞工之問卷調查結果作出簡單報告

當日出席發佈會的本會成員,包括鄭會友會長、物流業發

到立法會議員(航運交通界)易志明先生出席。是次發佈會吸引了九家媒體 到來採訪,包括:中國航務周刊、物流時代、東方日報、商報、文匯報 大公報、太陽報、經濟日報及商業電台。



當日鄭會長首先發言,感謝各大媒體到來,希望他們幫助業界多發聲音;之後,易議員亦簡介物流業對香港的重要性及土地 政策對物流業的影響。接著,陳鏡治先生撮要報告業界對上述問題的意見,用數字顯示物流業界面對土地及工人缺乏的情況 下的困境。同時反映業界對一億元培訓基金之另類用途

出席發佈會的香港貨櫃拖運業聯會主席黃兆華指出,業界現時的在職司機平均年齡已達50歲以上,屬行內第一代從業員,可 見業界多年來缺乏新血加入。他建議政府可考慮在每日150個單程證名額中加入一定的貨運司機名額, 紓緩業界的需要。各

### **Seminar – Enhancing Sales Skill and Revenue**



Selling is as easy as kicking a football; anyone can do it, but doing it well requires hard work and practice. The good news is that anyone can learn to sell well if he/ she wants to. The key contents of the workshop focused on three parts: generating methods to increase customer base and revenue, providing different angles to review existing customers, and adopting a systematic approach to talk with the customer with higher success ratio. We shared the above topics through some interactive activities such as brain storming, sharing and reaction exercise. Feedback received from the participants revealed that the workshop had provided them with good ideas and solutions on professional sales technique to generate more revenue. Most of the participants were willing to attend the similar workshop run by HKLA in the near future.

在大會上,澳門物流業發展委員會與中國物流與採購聯合會簽署了「戰略合作框架協議」,雙方將進一步加強合作關係。 為提升澳門物流業從業人員的素質,澳門特區勞工事務局及澳門生產力暨科技轉移中心共同簽署「合作項目備忘錄」,攜 手在澳門推動職業資格認證、專業培訓,以透過技能鑒定而達致"一試兩證"。是次活動為業界帶來一次難得的互動交流 機會,亦有助進一步推進兩岸四地經貿融合和深化合作。
