



Since the beginning of 2015 the service of my Presidency in HKLA has given me exciting new challenges. Without the support of our Council Members and the Administration office. I could hardly make it through. I am pleased to conclude what we have done during this period of time were remarkable and successful.



With the guidance and leadership of our Secretary General, Dr. Owen Yue and the Program and Recreation Committee Chairlady, Elsa Yuen, the YSHKLA had another fruitful year in 2015. The whole year program began with a meaningful Case Competition followed by Career Talk and Mock Interview. The overseas exchange in Vietnam with university students from Singapore, Hong Kong and Vietnam was the major yearly event and not to mention the company visits to Bausch & Lomb and Air Cargo Carnival in Hong Kong International Airport.

Support to HKSAR Government - The Logistics Policy Consultation

In the second quarter of 2015, HKLA had conducted a survey in regarding the Hung Shui Kiu New Development Area (HSK NDA) followed by a press conference in September. A position paper was submitted to the related Government departments, other logistics associations and institutes to draw the public attention on our proposal of smart utilization of the land in HSK NDA. Equally important was another proposal submitted to Transport and Housing Bureau concerning the Enhancing the Use of Port Back-Up Land in Kwai Tsing Area. We had also expressed our support of building the third runway to the Town Planning Board.

Membership Relationship Enhancement and Membership Drive

We paid visit to nine of our Corporate Members in 2015. We treasure the meeting opportunity and are thankful to their hospitality extended to the Association. We purposely invited three logistics professionals who are specialists in their sectors to join HKLA as Professional Member to share with us their professional experience. It is our honor to have them in our Association.

Academic and Profession Development - Education and Training

In 2015, we had organized 7 in-house training seminars for Members at free of charge. Those seminars covered a wide area of topics such as Internet of Things, Big Data, and Logistics Costing and Pricing etc. HKLA continues to be the external examiner and program advisors of logistics and supply chain management programs of Baptist University, Lingnam University, Hong Kong Productivity Council, and Hong Kong Polytechnic University. - 4. 為配合政府推動高增值物流,希望政府設立 培訓基金長遠補貼物流從業員每年\$2,000培 訓費於認可機構接受認可課程培訓提升技術 以應市場需要
- 5. 減免中小企物流公司利得税3%
- 6. 增加違例交通罰款後,車位時租及月租費用 必定上升,希望政府能在各繁忙路段提供多 一點泊車及上落貨位置




I am looking forward to seeing more students who can join the next case competition adventure in 2017.

2016 Hong Kong Logistics Case Competition was successfully held between 29 to 31 January 2016. A total no. of 51 students joined the competition. The competition strived to prepare students to handle workplace problems in their future career. With the support of KDS Global Logistics Limited, participants visited the KDS warehouse to learn more about its operations. Participants were also assigned to one of five different areas for conducting a study.

It has been a fruitful experience. Having limited time, participants worked hard to prepare their solutions. It was nice to have experienced and helpful mentors to support throughout the preparation. Through the discussions with participants from different study areas, there was stimulation of ideas. In business reality, it is important for us to consider various functions when

It was the first time for us to design the competition format as a simulated business meeting. Students had to propose a total supply chain solution which could meet KDS's requirement in supporting its new business practice. It is hoped that students would find this competition a valuable experience. There are still a lot of areas for improvement and we will continue to organize more events to enhance the students' interest in logistics.




This case competition provided a great opportunity, especially for year 1 students like us, to get in touch with the real logistics world. During the site visit, KDS staff explained the structure and the whole logistics process which helped us understand the daily operations of a warehouse and the importance of having effective time management. It was great for us to have close interaction with the staff to understand the realities of the operations. After the visit, we exchanged ideas with other teams in order to get a full picture of the case and exchange different questions and thoughts. Though our team encountered some obstacles, our mentors, all experienced professionals in the logistics field, gave us

some inspirational guidance. They pointed out potential problems with our plans, which helped us improve them to become more realistic. On the presentation day, the round table setting made us feel we were having a real conference with KDS staff. During the Q&A session, each team clarified their points enabling the groups to learn from each other. This was helpful for the total solution because not all teams fully understood all the tasks of different stages of the logistic process. This competition taught us the wider picture of the logistics industry and we learned that effective presentation skills are essential to attract and impress the audience.
