前海考察團



為更深入了解前海最新發展，香港物流協會於四月七日舉辦了前海一天考察團。

當日活動非常密集，首先參觀前海展示廳，令參與者初步了解到前海的開發和發展歷程。接著，前海管理局稅務管理署署長袁志雄先生與各參與者進行座談會，更深入地講解前海的發展是現代物流、供應鏈管理、創新金融、創新科技等多個產業。並提出有關前海的法律、醫療、教育、優惠政策等議題。其中提及很多參與者關注的稅項問題，利得稅低至15%，以吸引公司在前海做生意及工作。

接著參觀e站通服務大廳，了解如何以一站式簡易地做好商業相關登記手續。

參觀港貨中心時，參與者極主動地不斷向港貨中心負責人發問有關「香港正貨」進入中國的問題，同時亦了解如何在港貨中心中能做到 O2O (Online to Offline) 的生意模式。適逢考察當日為中國跨境電商零售進口最後一天按郵遞物品征收行郵稅。故各參與者重點討論，4月份開始執行的中國跨境電商零售進口新稅制，按貨物征收關稅和進口環節增值稅、消費稅。以推動跨境電商健康發展。

午飯過後，參與者前往「招商自貿商城」參觀。「招商自貿商城」作為招商局核下專營「海淘」的外國產品直接進口至中國，並進行銷售。提供如圖中百貨公司的線下店，令產品能實體顯示。

招商局集團有限公司前海蛇口自貿片區辦公室副主任邱文鶴先生，招呼參與者前往蛇口片區參觀招商局蛇口展示中心，沿途並介紹及講解招商局在物流業上的開發和發展歷程，讓各會員加深了解招商局的歷史及營運。參觀後，繼續與招商局代表進行座談，讓參與者從多角度了解其服務的項目及水平。

是次活動除了感謝上述各單位，要特別鳴謝香港特區政府駐深圳聯絡處大力支持及協助安排使考察團得以舉辦成功。

DHL Central Asia Hub Visit on 7 Apr 2016

During the visit to the DHL Central Hub, the staff introduced the whole process of receiving and reloading of parcels. The 'track and trace' system helps to identify the location and the status of the goods, and there are multiple checkpoints at the conveyor belts to monitor all the parcels are sent to the right place. The Hub adopts different systems for different size parcels, namely auto-coy and auto-flyer. The former is used for parcels weighing over 30kg while the latter is used for parcels or documents below 30kg. There is a sensor which can scan the barcode on any side of the goods. Once the barcode is scanned, the information is sent to the sorter that sorts the shipments according to the destination. Apart from the management of the warehouse, the back office systems play an important role in the whole operations. In the hub, there is a quality control center to monitor the shipping system and the real-time flight information. The staffs there are responsible to ensure the shipments are sent correctly. This visit has broadened the members' horizon on hub operations.

Some 25 members and participants attended this Educational Workshop on 10 March 2016. The basic principle of third party logistics (3PL) and the related activities were introduced. Costing and various pricing models were explained. Some cost and investment items that could be easily overlooked were identified. In the last section of the Workshop, participants in small groups were asked to list out costing elements of a suggested logistics operation. The 2.5 hours Workshop has received positive feedback from all participants.
