# **Taiwan Study Tour** 21 to 24 April, 2016







This Taiwan tour organized by the Hong Kong Logistics Association, provided comprehensive views into the latest technologies, operation workflows and facilities as well as the future direction of logistics development which can inspire the development of Hong Kong logistics industry.

Hsinchu Science Park was the first visit, which provided in-depth discussions in relation to the latest inventions and technologies, such as high sensitive RFID antenna, cloud, and Wi-Fi platform, to increase customer loyalty and productivity. Apart from studying advanced technologies, the Cold Chain, Good Manufacturing Practice (GMP) and Good Distribution Practice (GDP) facilities were investigated at Kerry TJ Logistics.

The state-of-the-art Automatic Storage and Retrieval System (ASRS), Warehouse Management System (WMS), and Standard Operating Procedures (SOPs) were well-developed in the cold storage facilities. On the other hand, Kerry TJ Logistics has been committed to developing a new concept of Automatic Distribution Terminals (APTs). Through visiting the operations and key facilities, Kerry TJ Logistics showed their capability to provide the best logistics services and the development of future planning.


Amway Taiwan Company Limited was another amazing and valuable visit. We were guided to visit their logistics facilities, call centers, and physical stores. The distribution center adopted the latest technologies, including ASRS system, temperature-controlled warehouse and specialized production lines. After the intensive site visits, we had a chance to experience the culture of Taiwan, by visiting the temple, Jiufen, Shifen, Taipei 101 etc.

In summary, the entire study tour was enjoyable and enlightening - giving inspiration to the Hong Kong logistics industry. 

## **HKLA Seminar:** Supply Chain Role in Merger & Acquisition on 26 May 2016

"Tax Inversion" has been a strong incentive for global companies to look for suitable M&A (Merger & Acquisition) opportunities since 1990's. After the 2008 financial turmoil and the subsequent worldwide QE (Quantitative

Easing) monetary policy, more M&A activities have been seen in the global market. Besides the significant reduction in profit tax, the low interest rates foster the best chance to grow the business quickly instead of the traditional slow organic growth

M&A usually comes with cost control as it involves debt from banks, private equity funds or other financial institutions. As a back-end support function, Supply Chain may face the challenges of expenses control as well as the integration of

various companies to a common platform. The positive side is that with a bigger business size, the opportunity for cost leveraging or bargaining is stronger. From an operational standpoint, Supply Chain folks need to be careful on handling the transition of M&A as it involves regulatory license transfer, proper stockpile decisions, different system & interface integrations, new suppliers, more complicated billing or logistics routing, certain hidden service risks and a more political working environment.

To tackle successfully, a positive attitude to embrace change is crucial. Learning quickly to upgrade oneself on new skills and be fair to each other during the people management are also essential to achieve a win-win situation.
