

亞洲食品與冷鏈合作組織



本會應亞洲食品與冷鍵合作組織邀請,參與於2017年7月11日至13日在大連舉行之會議。是次會議參與的冷鍵成員眾多,除了自身的亞洲成員 (中國、新加坡、日本、韓國、澳洲、新西蘭、菲律賓、印尼、越南、台灣)外,還包括美國、加拿大、意大利和墨西哥。在短短三天時間內成員相互交流,分享全球冷鍵走向、如何進一步保障食品安全、加強相互溝通、研製標準化的可能性等等。

是次合作組織的工作重點包括:

- 「一帶一路」戰略地結合,積極發佈國家最新政策解讀,幫助合作組織成員在大框架下獲得成功
- 推動泛亞太地區國家冷鏈標準的協同發展,構建通用標準,以降低跨境食品貿易的成本
- 編輯並出版泛亞太地區主要國家冷鏈發展及食品進出口貿易的報告,為貿易商與冷鏈服務商在企業決策中提供有價值的資訊參考
- 策劃並組織國際食品冷鏈會議,展覽和培訓活動,傳遞專業知識,分享行業最新動態,促進合作
- 組織亞太地區成員實地互訪考察,走進優秀食品貿易及冷鏈企業,加強組織成員之間的合作關係

總括而言,是次大會可以達到整合國際行業資源,實現優劣互補,享受整體協同效應,力求從整體的高度審視整個產業鏈的發展,為組織成員提供相關的增值服務。

香港物流人力市場 問卷調查及分析報告

本會代表業界向政府表達就人力資源供需對香港物流業發展的看法。於2017年7月25日至8月7日期間,本會透過問 卷調查採集業界對本港物流人力資源的意見,共收回問卷101份。

整體而言,目前本地大多數物流企業正面對前線員工招聘不足的難題。調查結果發現超過8成受訪企業的人力資源不 足,其中,超過6成欠兩成以下的人手。最難招聘的員工為:基層員工一倉庫(64.4%)及基層員工一運輸(53.5%)。 最多受訪者認為解決員工招聘不足的辦法是增加培訓機會及內部提升,和改善物流業界形象,吸引年青人入行。雖 然,受訪者並不認為輸入外地勞工是解決員工招聘不足的首要辦法,不過,大部份受訪者認為輸入外勞不會影響本 地員工就業。大部份受訪者願意為外勞支出與本地員工同等的薪金福利・同時・亦認為僱主應為外勞提供住所。不 過,輸入外勞帶來增加的成本,以及如何尋得合適居住地方並未有解決方案,這將會是輸入外勞政策的巨大阻力。

本會認為如果本港其他行業引進輸入外勞政策,一定程度上能舒緩目前本地勞工市場緊張的問題,最終全港人力資 源市場都會受惠,同時,物流業的問題亦會得以緩解。



VISIT TO CENTRAL MAIL CENTRE ON 6 SEP 2017




As a Hong Kong citizen, I have been enjoying the mail service of Hong Kong Post for years, but I never understood how it actually serves the public everyday. This HKLA visit to the new Central Mail Centre in Kowloon Bay impressed me a lot.

After 170 years of history, the latest green-design centre occupies 21,080 sq. meter with 5 floors integrating International Mail Centre and sorting centre in one place. I couldn't imagine that the post office processes over 3 million letters per day. The most surprising is the automation of identifying the mailing address: Optical Character Recognition (OCR) is applied to read the addresses on envelops including handwriting Traditional/Simplified Chinese and English addresses!

Besides, various operation flows were also introduced such as stamp chop automation and manual sorting for different post office branches. This visit has definitely broadened my insight and triggered more thoughts regarding e-Commerce small parcel handling.

HKLA SEMINAR: DIRECTORS' DUTIES AND RESPONSIBILITIES UNDER NEW COMPANIES ORDINANCE IN HONG KONG ON 7 SEP 2017

From the concept of shareholders to the concept of stakeholders, company directors of the board play a significant role in the 21st century. Boards are not only composed of shareholder representatives from different constituencies but also comprise different stakeholders. The Board's relations with associated parties including shareholders, employees, suppliers, customers, and the community at large are contained. Directors may not represent special interests or advocate the preferences of external parties if they are to carry out their fiduciary duties as a director. Board members retain responsibility for oversight and monitoring of any delegated functions.

The new Companies Ordinance and the subsidiary legislation commenced operation on 3 Mar 2014. The codification of directors' duties under section 465 imposes upon directors a new duty to exercise reasonable care, skill and diligence that would be exercised by a reasonably diligent person with dual tests. The corporate governance measures are enhanced through strengthening the accountability of directors and improving the disclosure of company information. Non-compliance with the direction from the Company Registrar is an offence. The company and every responsible person of the company will be liable to a fine. Directors are required to act on behalf of all stakeholders and exercise discretion and independent judgment in the best interests of the company.
